In March, The Irish Times reported that public bodies and government departments in Ireland show an "unacceptably high level of failure" to respond in time to the growing number of requests for information made since the new Freedom of Information Act was introduced in 2014.

Close to 34,000 requests were made in 2017, an increase of 67% since 2014, according to an annual report by Information Commissioner Peter Tyndall.

Tyndall said the struggles in meeting the public's requests "seem to me to be a strong indicator that public authorities are not devoting adequate resources to processing requests."

His statement is not too surprising, really, when you consider most public bodies and government departments still lack basic functions such as the ability to search audio and video files without first transcribing them into searchable text. That means the need to locate and extract information from sources such as videotaped council meetings significantly delays responses to requests as well as adds additional expense.

Additionally, the widespread use of email, text, instant messaging, and social media creates oceans of unstructured data to sort and sift through. Simply collecting these files often requires third-party assistance, which also adds additional time and expense along with unnecessary security risks.
